 - b. A question was asked regarding pins and if extra are needed. Submit requests to Curl PEI.
- 5) Be it resolved: the Provincial Championship Rules of Play be approved as presented.
 - a. Moved by Rod MacDonald, seconded by Sean Ledgerwood. Motion Carried. Amy reviewed.
- 6) Be it resolved: The playoff formats for the 2012-13 season be approved as presented.
 - a. Moved by Susan McInnis, seconded by Angela Hodgson. Motion Carried. Larry Richards opposed.
 - b. Amendment: Moved by Lester Wah, seconded by Blair Bernard. MC. Men's and Women's events will read:
 - i. Eight to twelve teams will play a triple knockout with a page playoff.
 - ii. Thirteen to fifteen teams will play two weekends: one being an open event which will be a triple knockout to determine the the final six (6) to advance to the second weekend. The final six will play a round robin with the top three advancing to a championship round where 2 plays 3 and 1 plays the winner.
 - c. Additional Motion: Moved by Susan McInnis, seconded by Sean Ledgerwood that the Provincial Mixed also follow these formats. Motion Carried.
- 7) Be it resolved: The following rule be added to the Specific Rules of Play for the Provincial Dominion, in order to maximize the number of eligible curlers:

The Provincial Dominion Curling Club Championship will not be held during either weekend of March Break.

- 8) Be it resolved: Rule # 18, regarding practice time, be changed from ten to eight minutes.
 - For each game, unless otherwise determined, both teams must be present and READY to go on the ice 30 minutes prior to game time. A coin toss for choice of practice time or colour will be done at that time. Failing to be present means you forfeit both last rock and rock colour. During practice, each team shall be allowed to throw eight rocks each way, or have a maximum of eight minutes (whichever comes first).
