CONSENT FORM AND WAIVER

**AUTHORIZATION FOR RELEASE OF INFORMATION AND/OR

FOR MEDIA AND PUBLIC RELATIONS PURPOSES & RELEASE OF LIABILITY, WAIVER OF CLAIMS,
ASSUMPTION OF RISKS & INDEMNITY AGREEMENT**

I hereby give consent to Rogers Sportsnet Inc. (hereinafter "RSI") to take and use images (photographs or videotape) or sounds recordings of me and to disclose information about me to or in any public media, including radio, television, internet or print, or in a publication. I understand that the intended use of such images and information is for advertising, marketing, fundraising or promotional purposes of the Junior Grand Slam of Curling. I hereby waive the right to or interest in the images or the confidentiality of the information disclosed to the public, as contemplated in this release.

I acknowledge that this consent to use images and authorization for release of information is being made solely for the benefit of RSI and without any expectation of compensation or other benefit to me. To the extent that any benefit accrues or might accrue to RSI from the use of images or disclosure of information, I hereby and forever waive any interest in or claim to such benefits.

I hereby release and forever discharge RSI (including without limitation all corporate affiliates and officers, directors, trustees, employees, medical staff members and agents) from any and all claims, liability, actions, suits, demands, costs, expenses or indebtedness arising out of, related to, or in any way connected with the use of images or disclosure of the information and materials described herein, and I hereby waive all rights and interest in and to such information and materials.

I fully understand, acknowledge and agree that participating in the Activity presents inherent risks and dangers, not all of which can be listed but may include: Symptoms arising from demanding physical movements and related physical exertion; all manner of injury arising from falling and impacting against the floor or ice surface, walls or rink boards, or apparatus/equipment; impacting with other participants, or equipment which includes, but is not limited to, game equipment such as: curling rocks, brooms, helmets, sliders; abrasions, bruises, blisters or cuts; an increased load on the heart, which may result in dizziness, shortness of breath and in extreme circumstances, may result in a heart attack; potential for bone and muscular skeletal injury, such as sprains and strains; episodes of light headedness, fainting, chest discomfort, leg cramps and nausea; and travel to and from the arena and the potential for a motor vehicle collision, mechanical failure or human error. I further acknowledge and hereby accept any and all risks and hazards associated with my voluntary participation in the Activity including those due to NEGLIGENT ACTS OR OMISSIONS OF THE GRAND SLAM OF CURLING and ITS BOARD OF GOVERNORS, OFFICERS, DIRECTORS, AGENTS, EMPLOYEES or VOLUNTEERS (the "RELEASEES"), INCLUDING ANY FAILURE TO SAFEGUARD OR PROTECT ME FROM THE POSSIBILITY OF BODILY INJURY, DISABILITY, DEATH, DAMAGE TO PROPERTY OR LOSSES RESULTING THEREFROM.

HEALTH CARE COVERAGE: I acknowledge that I am responsible for my own health insurance. I understand and agree that the Releasees are not responsible for any health or medical or dental expense I may incur as a result of participating in the Activity.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT: In consideration of my voluntary participation in the Activity, I hereby:

- **RELEASE** the RELEASEES from any and all liability for any personal injury, disability, death, property damage or loss I may suffer as a result of my participation in the Tournament, FOR ANY CAUSE WHATSOEVER, including negligence or breach of contract or breach of any legal or statutory duty, on the part of the Releasees, including any failure to protect or safeguard me from injury, disability, death or loss; and
- **WAIVE ANY AND ALL CLAIMS, DEMANDS, SUITS AND ACTIONS** that I or my heirs, successors, executors, administrators, representatives and assigns may have against THE RELEASEES for any personal injury, disability, death, property damage or loss arising directly or indirectly from my participation in the Activity; and
- **HOLD HARMLESS AND INDEMNIFY** THE RELEASEES from any and all liability for any property damage or losses or injury to any third party resulting from my participation with the Activity; and
- **AGREE** this agreement shall be governed by and interpreted in accordance with the laws in the Province of Prince Edward Island.
